#### PERSONAL DATA PROCESSING POLICY

#### FOR WEBSITES http://премиявызов.рф, www.vyzovaward.com

(consent to personal data processing and consent to distributing personal data to third parties)

This document, the Personal Data Processing Policy (hereinafter referred to as the Policy) is the set of rules and regulations for the use of User's personal data by the VYZOV Foundation for the Development of Scientific and Cultural Relations (hereinafter referred to as the Administrator/Operator).

#### **Terms and Definitions:**

- a) **Operator of Personal Data/Operator**: VYZOV Foundation for the Development of Scientific and Cultural Relations (OGRN (Primary State Registration Number) 1237700439019), registered in the register of operators engaged in personal data processing established by the Federal Service for Supervision of Communications, Information Technology and Mass Media of the Russian Federation, organizing and (or) carrying out the processing of personal data individually or jointly with other parties, as well as determining the purposes for processing personal data, the composition of personal data to be processed, and actions (operations) performed with personal data.
- b) **Personal Data Processing**: any action (operation) or a combination of actions (operations) performed with personal data, both automatically and manually. Personal data processing includes the following actions (operations) with personal data:
- collection;
- recording;
- arrangement;
- accumulation;
- storage;
- specification (updating, changing);
- extraction;
- use:
- distribution (transfer, submission, providing access);
- anonymizing;
- blocking;
- deletion;
- destruction.
- c) **Website:** official websites of the Prize accessible on the Internet at <a href="http://премиявызов.рф">http://премиявызов.рф</a>, www.vyzovaward.com (including subdomains).
- d) **Prize:** the VYZOV National Prize in Future Technology, a public competition held annually since 2023.
- e) User: any visitor of the Website.
- f) **Personal Data Subject:** an individual who can be directly or indirectly identified or specified using personal data.
- g) **Prize Participant:** the author (co-author) of a Project who meets all the requirements specified in the VYZOV National Prize in Future Technology regulations (hereinafter referred to as the Regulations), who has submitted an application on the Website for participation in the Prize, and who aims to use, is using or has used the Website's functionality in order to participate in the Prize held by the Administrator.
  - in case of self-nomination, the Application shall be submitted personally by the author (group of authors) who becomes (become) both the Applicant and the future Prize Participant after the Application has been checked by the Organizing Party in accordance with the Regulations.
  - in case of nomination of the Project by a third party (Applicant), the future Prize Participant shall be the author (co-authors) of the Project whose data was stated in the Application and who meets the Regulations criteria.

## 1. General Provisions

1.1. By agreeing to use the Website and accepting the User Agreement posted on the Website, the User shall (freely, voluntarily and in their own interest) grant indefinite irrevocable written consent to any methods of processing their personal data, including any action (operation) or a set of actions (operations)

performed manually or automatically, including the methods explicitly listed in the definition of "Personal Data Processing" for the purposes set out in this Policy.

- 1.2. This Policy, including the interpretation of its provisions and the procedure for its adoption, execution, modification, and termination, shall be governed by the laws of the Russian Federation.
- 1.3. The Policy may use other terms and definitions not specified in the "Terms and Definitions" section of this Policy. In this case, such term shall be interpreted in accordance with the text of the Policy and the User Agreement posted on the Website. In the absence of an unambiguous interpretation of the term or definition in the text of the Policy, it shall be interpreted based on the mandatory documents specified therein (primarily), the legislation of the Russian Federation (secondly), and business practices and scientific principles (subsequently).
- 1.4. This Policy has been drafted in accordance with Federal Law 152-FZ "On Personal Data" dd. July 27, 2006.

#### 2. Personal Data

- 2.1. Personal data mentioned in this Policy shall mean:
- Information that the User personally provides about themselves during registration or authorization, when filing an Application, as well as in the process of further use of the Website, including, but not limited to, the User's personal data: name, surname, patronymic, year, month and day of birth, citizenship, address, phone number, email address, gender, passport data, scanned copy of passport, education, place of work, position held, place of study, phone number and other personal data that the User shall provide to the Operator during the use of the Website.
- Data that is transferred automatically depending on the User's software settings, including, but not limited to: IP address, cookies, telecom provider, data regarding the software and hardware used by the User to access the communications network, including the Internet, communication channels, information and materials sent and received when using the Website.
- 2.2. The Administrator is not responsible for the use of the User's personal data by the third parties that the User interacts with while using the Website.
- 2.3. The Administrator has the right to establish requirements for the specific User's personal data that must be provided in order to use the Website. If certain information is not marked as mandatory, the provision or disclosure of such personal data shall be carried out by the User at their own discretion.
- 2.4. The Administrator has the right to verify the authenticity of personal data, namely passport details, by requesting that the User provide a scanned copy of their passport or other document confirming the User's identity. With respect to the remaining data, the Administrator shall assume that the User acts honestly and in good faith while making all necessary effort to keep such personal data up to date.

### 3. Purposes for Processing (and Distribution) of Personal Data

- 3.1. The Administrator shall carry out the processing (including collection, storing, and distribution) of only that part of personal data that is required to conclude and execute agreements with the User.
- 3.2. The Administrator shall be entitled to use personal data for the following purposes, including, but not limited to:
- concluding agreements with the use of the Website, including agreements with third parties;
- fulfilling obligations under the agreements, including providing the User with technical support and the opportunity to use the Website;
- identifying the User when fulfilling obligations under the agreements concluded with the User;
- ensuring communication with the User when providing them with information services and improving the quality of services;
- issuing notifications under the concluded agreements, including with the involvement of third parties;
- conducting marketing, statistical and other research based on depersonalized data;
- ensuring the participation of the Prize Participant in the Prize, in case of completing a certain stage and further participation in the Prize, in accordance with the Prize Regulations; distribution of personal data of the Participant on terms specified in the Consent to Personal Data Processing Approved for Distribution by the Personal Data Subject contained in Appendix No. 1 to this Policy.

#### 4. Requirements for the Protection of Personal Data

4.1. The Administrator shall store personal data and ensure its protection from unauthorized access and distribution in accordance with internal rules and regulations.

- 4.2. The User's personal data shall remain confidential, except in cases where the technology of the service provided or the settings of the software used by the User involve an open exchange of information with other participants and Internet users.
- 4.3. In order to improve the service quality, the Administrator shall have the right to store the log files with the information about the actions performed by the User while using the Website, as well as related to the conclusion and execution of the Agreement and other agreements by the User, on their part.

#### 5. Transfer of Personal Data

- 5.1. The Administrator shall transfer personal data to third parties in the following cases:
- the User has agreed to such actions, including in the cases when the User uses the software settings that do not limit the provision of certain personal data;
- such transfer is necessary for the Prize Participant to be able to use the Website's functionality;
- such transfer is required for the conclusion and execution of agreements with the use of the Website;
- following the official request issued by a court or any other authorized state body under the procedure established by law;
- in order to protect the rights and legitimate interests of the Operator should the agreements concluded by the User be violated;
- in order to ensure the Participant's participation in the Prize;
- in order to inform the general public about the Participant's participation in the Prize, as well as about the Prize itself, its stages and results.

### 6. Consent to Personal Data Processing. Consent to Personal Data Distribution.

6.1. The processing (and distribution) and protection of personal data shall be carried out only upon receiving the User's consent which can be expressed orally, in writing, or in any other form provided for by applicable law, including through the performance by the Personal Data Subject of implied actions when using services on the Website, completing the registration procedure on the Website and acceptance of offers containing provisions on personal data processing in accordance with applicable law. In the absence of the consent of the Personal Data Subject to processing of their personal data, such processing shall not be carried out.

## 7. Amendments to the Personal Data Processing Policy

- 7.1. The Policy may be amended or terminated by the Administrator unilaterally without notifying the User in advance. The new version of the Policy shall come into force from the moment it is posted on the Website, unless otherwise provided by the new version of the Policy.
- 7.2. The most recent and currently active version of the Policy is posted on the Website.
